AIRPORT FACILITY AGREEMENT

1. Renter agrees not to use nor permit the use of the rental space for any other purpose other than the storage of the aircraft and other related miscellaneous aircraft accessories.
2. Renter agrees not to use this space for any commercial aircraft activities unless written authorizations are received by the Airport.
3. All fixtures, improvements and additions made in or upon the leased property, whether by either party hereto, shall remain upon the premises at the termination of this agreement without compensation or payment by the Airport.
4. Parking of Aircraft is by assignment. Do not park in unauthorized places. Report defective tiedowns or safety related concerns.
5. Taxiing of Aircraft shall be done at a slow speed and shall be done on hard surfaces only. The Airport will not be held responsible for negligence due to taxiing. Observe caution when taxiing and stay on pavement.
6. Obey all signs and use caution when operating the electric security gates.
7. The Airport will provide the following services:
(a) Electricity for Hangar (b) Water for washing planes.
8. Non payment of an account when due will result in the filing of a warehouseman's lien on the subject aircraft.
9. Renters and pilots will abide by all FAA rules and regulations and WHA Rules and Regulations, as well as all rules herein stated. A copy of the Airport's Rules and Regulations are available on request.
10. The Airport reserves the right to cancel or withdraw service to anyone at any time at its sole discretion.
11. Monthly billing terms are "NET ON INVOICE". Certain discounts allowed for prompt payment.
12. The Airport does not provide security for aircraft and related rental space. Lock plane and secure it at your own risk. Use of Airport and its appurtenant areas are at owner's own risk.
13. Renter agrees to pay all of Airport's expenses, including attorney's fees, in enforcing any of the obligations of this agreement, or in any proceedings or litigation in which the Airport shall become involved, by reason of the renter and renter hereby agrees to indemnify and hold Airport harmless from or against any acts by or on behalf of the renter.
