ATC PRIVATIZATION STATUS.... WE CAN NOT LET THIS HAPPEN

Former US Airways pilot Chesley "Sully" Sullenberger, made famous along with First Officer Jeffrey Skiles for their successful ditching of US Airways Flight 1549 on the Hudson River in 2009, is taking a very public stand against air traffic control privatization (H.R. 2997)—and he's asking all of us pilots to join him.

Sullenberger's aviation career has spanned more than 50 years and includes general aviation, military, and airline experience. He contends that privatizing ATC "would allow a corporate monopoly to make decisions that put profits ahead of safety and would devastate rural communities." He also concludes that such a move would be a "threat to our nation's security, safety, access, and basic fairness." Go to NBAA 's website to see Sully's comments and video.

Proposals for privatizing ATC, long-championed by the big airlines, have been promoted as part of the continuing congressional debate over reauthorization of funding and programs for the Federal Aviation Administration (FAA). Under such proposals, congressional oversight of the nation's aviation system would be replaced by an entity governed by a

private board of directors. Basically, you'd have to 'lawyer up' if an issue came up. Our congressional delegation is in charge of our public airspace-lets keep it that way.

As the legislation stands now, the House of Representatives has not taken a vote. This means that Rep. Schuster (a primary supporter of privatization) will be taking up the legislation again in September, after the Congressional break.

If you have not contacted your congressman and senator, it is not too late.

Keep the efforts strong.


